This action has led to legal challenges, with critics arguing that it violates the ICA by withholding funds for policy reasons not authorized under the Act. ()

For example, activists discovered in the 1980s that the Environmental Protection Agency knew that paper mills were polluting toxic waste into rivers. Background Info Article II, Section 3 of the Constitution stipulates that the President has the authority to adjourn Congress in the event of a dispute over the time of adjournment. President Trump has suggested that he might employ the adjournment power for the purpose of making recess appointments, circumventing the traditional process of Senate confirmation. () Will President Trump formally invoke the Insurrection Act before 2026? Show Resolution Criteria and Background Info Resolution Criteria This question will resolve as Yes if credible sources report that President Trump has formally invoked the Insurrection Act before January 1, 2026. Fine Print - The invocation must explicitly invoke the Insurrection Act or make reference to the legal provisions under the Act. A statement by Trump saying he could invoke the Act would not qualify. - Metaculus will resolve this question according to credible sources. Background Info The Insurrection Act grants the president authority to deploy the US armed forces for domestic law enforcement purposes without specifying the conditions under which this authority may be used. Show Resolution Criteria and Background Info Resolution Criteria This question will resolve as Yes if credible sources report that the U.S. Department of Justice (DOJ) announces a new investigation or prosecution of a Democrat who meets any of the following criteria before January 1, 2026: - Has served as President or Vice President of the United States. - Has held any of the following leadership roles in the House of Representatives or Senate (Speaker of the House or House Minority/Democratic Leader,

Senate Majority or Minority/Democratic Leader, House or Senate Majority/Democratic Whip). - Has served as an impeachment manager during either of the impeachment proceedings against Donald Trump (2019-2020 or 2020-2021). The 2019-2020 impeachment managers were Adam Schiff, Jerry Nadler, Zoe Lofgren, Hakeem Jeffries, Val Demings, Sylvia Garcia, and Jason Crow. The 2020-2021 impeachment managers were Jamie Raskin, Diana DeGette, David Cicilline, Joaquin Castro, Eric Swalwell, Ted Lieu, Stacey Plaskett, Madeline Dean, and Joe Neguse. Fine Print - The DOJ must publicly and officially announce the initiation of an investigation or prosecution against the individual. - The resolution does not require a conviction or final outcome—only the announcement of a formal investigation or prosecution. - For clarity, the question includes impeachment managers formally appointed for Trump's impeachment proceedings and leadership roles active as of the time of the DOJ's announcement. -Metaculus will resolve this question based on credible sources. Background Info During his 2024 presidential campaign, Donald Trump repeatedly vowed to pursue investigations and prosecutions against political opponents. Prosecution of a highprofile Democrat by the DOJ under the Trump administration would reflect a notable shift in precedent given these campaign promises. ()

Will Elizabeth MacDonough, the current Senate parliamentarian, be removed or resign by June 30, 2025? Show Resolution Criteria and Background Info Resolution Criteria This question will resolve as Yes if credible sources report that the current Senate parliamentarian, Elizabeth MacDonough, has been removed from office or resigned before July 1, 2025. Fine Print - This guestion will resolve to Yes only if there is credible and verifiable reporting from reputable sources confirming that Elizabeth MacDonough has either: 1) Resigned from her position as Senate parliamentarian, or 2) Been formally removed from the role, or 3) Lost her role because it has been abolished. - A resignation or removal must be official and publicly

The current Senate Parliamentarian, Elizabeth MacDonough, has held the position since 2012. ()

Will the White House revoke the media credentials of reporters from two media outlets before 2026? Show Resolution Criteria and Background Info Resolution Criteria This question will resolve as Yes if credible sources report the White House revokes the media credentials of two or more reporters from at least two previously credentialed media outlets before January 1, 2026. Fine Print -This question will resolve to Yes only if the White House formally revokes the media credentials of two or more reporters from at least two media outlets that were credentialed by the White House at any point prior to the revocation. - The revocation must apply to reporters from the specific outlets and be publicly announced by the White House or reported by credible news sources. The question still resolves to Yes even if the credentials are later restored. - There is no limitation on when the reporters were initially credentialed; they must only be credentialed at the time of the revocation. - Metaculus will resolve this question according to credible sources published on or before January 1, 2026, Eastern Time. Background Info President Trump has long enjoyed a contentious relationship with mainstream media, which he terms "fake news." His first administration revoked the White House press passes for dozens of journalists. Further, near the end of the 2024 campaign, many journalists were denied access to an election watch event. ()

Will the National Archivist certify and publish the Equal Rights Amendment to the Constitution by June 30, 2025? Show Resolution Criteria and Background Info Resolution Criteria This question will resolve as Yes if the National Archivist certifies and publishes the Equal Rights Amendment (ERA) to the Constitution before June 30, 2025. Fine Print - This question will resolve to Yes only if the National Archivist officially certifies the ERA and publishes it as part of the official records, indicating that it has been added to the U.S. Constitution. - Metaculus will resolve this question according to credible sources or official announcements from the National Archivist. Background Info The Equal Rights Amendment (ERA) is a proposed amendment that would prohibit sex discrimination. It was passed by Congress in 1972 and submitted to the states with a seven-year ratification deadline, later extended to three years, causing the deadline to be 1982. 35 states initially approved the amendment before the deadline passed. However, several states rescinded their ratification while others ratified the amendment after the deadline, raising questions about whether a statutory ratification deadline is constitutional and whether states can rescind ratification. In the final days of his Presidency, Joe Biden declared that the ERA was part of the Constitution. However, this statement has no legal effect unless the Archivist certifies the Amendment, which they have yet to do. ()

Will the United States and Denmark announce formal negotiations over the possible transfer of sovereignty of Greenland to the United States before 2026? Show Resolution Criteria and Background Info Resolution Criteria The question will resolve as Yes if the governments of both the United States and Denmark, separately or jointly, announce formal negotiations over the possible transfer of sovereignty of Greenland to the United States by January 1, 2026. Fine Print - This question will resolve to Yes only if the United States and Danish governments formally and publicly announce negotiations, such as via a press conference, official statement, etc. - This question will not resolve to Yes if it is only reported via news organizations that there are back channel, private, or other non-public negotiations/discussions occurring between officials in the two governments. - Metaculus will resolve this question according to official announcements from the United States and Denmark before January 1, 2026, Eastern Time. Background Info Greenland is an autonomous territory with just under 60,000 people within the Kingdom of Denmark. Greenland has control over its domestic affairs while Denmark retains authority over foreign affairs and military matters. The geographic location of Greenland, as well as its deposits of oil and minerals, makes it a valuable strategic and economic asset. President Trump has publicly expressed a desire to obtain Greenland as an American possession. The transfer of sovereignty of Greenland would mark an unprecedented move of territorial expansion and exchange between Western powers. ()

Will the Department of Justice or Education open a civil compliance investigation into whether diversity-related programs at Harvard constitute illegal discrimination or preferences before 2026? Show Resolution Criteria and Background Info Resolution Criteria This question will resolve as Yes if credible sources report that the U.S. Department of Justice (DOJ) or Department of Education (DOE) has opened a civil rights or Title VI compliance investigation into whether diversity-related

programs at Harvard University constitute illegal discrimination or preferences before January 1, 2026. Fine Print - The investigation must be officially announced by the DOJ or DOE and must explicitly cite concerns about discrimination or preferences related to diversity-related programs at Harvard University. - "Diversity-related programs" refer to institutional initiatives. policies, or practices aimed at increasing representation or inclusion of underrepresented groups, such as affirmative action, diversity training, or DEI (Diversity, Equity, and Inclusion) initiatives. If no investigation is announced or if it is determined that any investigation does not meet these criteria, this question will resolve as No. Background Info The question of whether diversity-related programs at elite universities constitute illegal discrimination has been a contentious issue in recent years, particularly following the Supreme Court's decision in Students for Fair Admissions v. Harvard, which ended race-conscious admissions policies at U.S. colleges and universities. The Department of Justice and Department of Education have both historically taken an interest in investigating compliance with civil rights laws at universities. Recent developments, including legal challenges and policy shifts at institutions like Harvard, have raised questions about whether such programs might face increased scrutiny. ()

Will any senior executives of these major public companies be imprisoned for corporate crimes before 2026? Show Resolution Criteria and Background Info Resolution Criteria This question will resolve as Yes if any senior executive (current or former) is convicted of crimes relating to actions taken in a corporate capacity (ie ignoring crimes committed which are unrelated to their companies and crimes committed for their own benefit at the expense of their employer (eg insider trading)), and their prison sentence begins between January 1, 2021 to January 1, 2026. Senior executives are those executives and directors who are named on official filings to their respective stock exchanges. An executive will be eligible in this question if they are employed by a company that was listed in any of these major indices at any time in 2021 or later, even if subsequently delisted: -S&P500 - FTSE100 - DAX40 - CAC40 - FTSE MIB - Nikkei 22 Background Info In 2006 Jeffrey Skilling was imprisoned for 12 years for his part in the Enron scandal. Since then, there have been very few high profile convictions of corporate bad-actors. (Much ink was spilled over the lack of convictions of bankers during for the 2007-2008 financial crisis) There have been prison terms for some more junior employees. Tom Hayes was imprisoned for his part of the LIBOR fixing scandal although generally executives have escaped sanctions: There are currently outstanding warrants for Wirecard executives. and a former VW CEO is facing charges of fraud in court. (His imprisonment would result in this question resolving positive) ()

Will there be any reported human-to-human transmission of highly pathogenic avian influenza H5N1 globally before 2026? Show Resolution Criteria and Background Info Resolution Criteria This question will resolve as Yes if, after July 17, 2024, and before January 1, 2026, the US Centers for Disease Control and Prevention (CDC) reports that at least one case of human-to-human spread of highly pathogenic avian influenza H5N1 has occurred globally. Fine Print - Reports that express degrees of confidence in the spread of human-to-human transmission will also

count if they refer to a specific case. For example, if CDC reports that a specific infection of H5N1 in an individual was likely spread from another human this question will resolve as Yes. - An assessment that humanto-human spread is possible, plausible, or other language that does not clearly indicate that human-to-human transmission more likely than not occurred in at least one specific case will not be sufficient. - For the purposes of this question, all descendant lineages of H5N1 will count as H5N1. Background Info Highly pathogenic avian influenza (HPAI) H5N1 has been a serious concern since it emerged in the early 2000s. While rare, some cases of human infection have been reported, with the primary mode of transmission being from infected poultry. However, human-to-human transmission has not been documented at significant levels. The CDC and other health agencies continue to monitor outbreaks, and the possibility of human-to-human transmission is a key factor in assessing pandemic potential. ()

Will real housing prices in the US increase more in 2025 compared to 2024? Show Resolution Criteria and Background Info **Resolution Criteria** This question will resolve based on the Zillow Home Values Index (ZHVI) and specifically the "ZHVI All Homes (SFR, Condo/Co-op) Time Series, Smoothed, Seasonally Adjusted(\$)" data type for "Metro & U.S.". It will resolve as Yes if the relative change of the ZHVI for the United States from November 2024 to November 2025 is greater than the relative change from November 2023 to November 2024, when adjusted for inflation. Fine Print - For example, the same question for 2024 vs 2023 would have resolved as Yes because 1. The ZHVI for November 2022 was \$339,428, for November 2023 it was \$347,035, and for November 2024 it was \$355,876. 2. Adjusted for inflation using the BLS CPI Inflation Calculator, we get the prices \$359,702 (Nov 2022) and \$356,576 (Nov 2023) in Nov 2024 USD. 3. The ratio Nov2024 / Nov2023 is \$355.876 / \$356.576 = 0.998, greater than the ratio Nov2023 / Nov2022 which is \$356,576 / \$359,702 = 0.9913. - If Zillow stops reporting the ZHVI or

if the ZHVI substantially changes its methodology, this question will be annulled. -If the BLS CPI Inflation Calculator is not available, another month-level US CPI inflation calculator may be used. - The latest numbers for the ZHVI as of December 2025 will be used to resolve this question, including any revisions to the 2023 or 2024 estimates. Background Info The United States housing market has experienced significant fluctuations over the past few decades. After recovering from the 2008 financial crisis, which was largely triggered by the subprime mortgage collapse, housing prices saw steady appreciation throughout the 2010s. This trend accelerated dramatically during the COVID-19 pandemic, driven by historically low interest rates, limited housing inventory, and changing work patterns. Nominal house prices fell slightly at the end of 2022, but have been rising since. Criteria and Background Info Resolution
Criteria In 1928, biologist Alexander Fleming
discovered - by accident - that where the
Penicillium mould had grown on a petri dish
the bacteria nearby had been killed. This was
due to a chemical the mould secreted, which
he named "penicillin" - the antibiotic we know
and love today. Since the discovery of
penicillin, antibiotics have saved hundreds of
millions of lives and become an essential part
of modern medicine. But they're getting less

effective. Repeated use has led to the existence of resistant strains of bacteria, which are immune to the effects of multiple different antibiotics. This has been described as a "serious, worldwide threat to public health" by the WHO. More recent data on their website suggests the figure is more like 37,000. Will the United States score in the bottom 50% for academic freedom in 2025 (according to the AFI)? Show Resolution Criteria and Background Info Resolution This question will resolve as a Yes if the United States of America is ranked in the bottom 50% for academic freedom in 2025, which includes the following brackets: Bottom 10%, Bottom 10-20%, Bottom 20-30%, Bottom 30-40%, and Bottom 40-50%, according to the Academic Freedom Index. This question will resolve as a No if the United States of America is ranked in the top 40-50% or higher on the Academic Freedom Index for the year 2025. This question will resolve as ambiguous if the Academic Freedom Index is no longer published, if the AFI does not report data for the year 2025 (but does report data for 2026 or later), or if the AFI does not report the 2025 data by December 31, 2028. Fine Print It is anticipated that the report for the year 2025 may not come out until 2026 at the earliest. Resolution happens when the report is released, unless the condition of ambiguous resolution are met. Background Info The Academic Freedom Index (AFI) is a comprehensive and widely recognized tool for assessing de facto levels of academic freedom across the world. The AFI evaluates five key indicators of academic freedom, including the freedom to research and teach. freedom of academic exchange and dissemination, institutional autonomy, campus integrity, and freedom of academic and cultural expression. The index currently covers 179 countries and territories, and is considered the most comprehensive dataset available on the subject of academic freedom. The index employs a methodology that includes assessments by 2,197 country experts, standardized questionnaires, and a well-established statistical model. implemented and adapted by the V-Dem project. The 2023 report (of the period up to December 2022) places the United States of the America in the Top 40-50% bracket (pg. 2-3) and outlines the following threats to academic freedom: "China, India, the United States of America and Mexico are among the most populous countries where academic freedom has significantly fallen back over the past decade. These developments have occurred in different political settings and do not all follow the same pattern." "The United States of America presents a different picture. After a long period of relatively high academic freedom levels, four out of five indicators visibly declined in 2021 - the year after President Donald Trump, who repeatedly made statements highly critical of science and academia, was voted out of office. Although some federal actions detrimental to academic freedom were taken during his administration, educational matters in the USA are largely regulated by individual states, which have increasingly used their authority to interfere in academic affairs since 2021. At least nine states, all Republican-led, have adopted bills that ban the teaching of concepts related to "critical race theory" in higher education institutions. Several states are also targeting tenure in public universities, adding to the already precarious status of academic employment. Some states now also allow students to record class lectures without the professor's consent. Furthermore, influential conservative groups are lobbying state legislatures to withdraw funding from scientific fields such as gender, minority studies, and environmental science, and various groups are maintaining public "watchlists" of professors perceived as radical leftists. Despite efforts to polarize and intimidate, AFI data on academics' freedom of expression

indicates that scholars in the USA remain able to publically voice their expertise, even on politically salient issues." () Will the 12-month percentage change in the US Consumer Price Index be lower in November 2025 than it was in November 2024? Show Resolution Criteria and Background Info Resolution Criteria This question resolves as Yes if the 12-month percentage change in the US Consumer Price Index (CPI) in November 2025 is lower than it was in November 2024, as reported by the St. Louis Fed at the following location: Consumer Price Index for All Urban Consumers: All Items in U.S. City Average (CPIAUCSL) If the 12month percentage change in the CPI in November 2025 is greater than or equal to where it was in November 2024, this question resolves as No. Fine Print At the time of this question, for November 2024 this value is 2.73258 percent. Background Info Inflation was a top issue in the 2024 US presidential election, with Donald Trump saying in his September 10th debate with Kamala Harris, "We have inflation like very few people have ever seen before. Probably the worst in our nation's history." Trump has vowed to take a more active role in setting interest rates, telling reporters, "I feel the president should have at least say in there, yeah. I feel that strongly. I think that, in my case, I made a lot of money. I was very successful, and I think I have a better instinct than, in many cases, people that would be on the Federal Reserve or the chairman." A recent report from Moodys estimates an inflation rate of 3.5% in 2025. "fueled by the higher tariffs, outflow of foreign immigrants, the resulting tighter labor market and more quickly rising labor costs, and taxcut-fueled fiscal stimulus." On the other hand. some experts have predicted that the Department of Government Efficiency could put downward pressure on inflation through tax cuts and reduced government spending, which may counteract the effects of policies such as tariffs. () Will Freedom House report that internet freedom has declined every year until 2025? Show Resolution Criteria and Background Info **Resolution Criteria** This question resolves

positively if for each year until 2025, inclusive, Freedom House reports more countries with a decrease in their internet freedom scores than with an increase. **Background Info** The Freedom on the Net report is an annual report on internet freedom worldwide, produced by Freedom House. It tracks changes in internet regulation across 65 countries. As of the 2020 edition, it claimed that freedom had been on the decline (operationalised as more countries' scores decreasing than increasing) for ten years in a row, with 26 countries' scores worsening and 22 improving in 2020.
